



Visitor Parking Pass: 2015 Program FAQs

How do I request a VPP? How much does it cost?

The 2015 VPP registration process will begin October 1, 2014. At this time, an **annual VPP is free** for eligible residents.

Who is eligible for an annual visitor parking pass (VPP)?

The VPP will be available to eligible households in Wards 1, 3, 4, 5, 6, 7 and 8 as well as ANC 2F.

If my ANC isn't eligible for a VPP, how can I change that?

Residents should **petition** their **Advisory Neighborhood Commissions (ANC)** to **opt-in** for the Visitor Parking Pass program. A formal resolution from the ANC must be submitted to DDOT and accepted. DDOT will publish final rulemaking to include soliciting ANCs.

How many VPPs can my household get?

Each household may only receive **one annual VPP**. For **additional passes**, residents may **request a temporary visitor parking permit from** their local Metropolitan Police Department station or substation. What if I live in a group home setting? Can each tenant get a VPP?

A household is defined as all tenants living in a single family home (attached, semi-detached, or detached), a residential unit in a condominium, a residential cooperative unit, a residential unit in a flat, or a residential apartment in an apartment building. As such, only **one** annual **VPP** would be granted **for** the use of **all tenants in the household**.

Where can I use a VPP?

The VPP can <u>only</u> be used **within** the **ANC** area **indicated on the pass** and the enclosed map accompanying the pass. ANC maps can also be located online at http://www.ancdc.us/.

Who can use a VPP?

Any visitor granted the VPP from an eligible resident, to include commercial vehicles actively engaged in construction, maintenance, repair, or reconstruction work at a residence within the ANC. The VPP can be used on any motor vehicle even though the motor vehicle displays a residential permit parking (RPP) sticker for another zone.

How long will the VPP be valid for?

The VPP will be valid during a single calendar year (from January 1 through December 31) as indicated on the pass.

What parking privileges does a VPP grant and not grant the user?

A VPP grants the user, displaying the VPP properly on the driver side dashboard, **temporary residential permit parking privileges** during the hours and days that RPP restrictions on the block are enforced. The VPP **does not waive** the requirement to register one's vehicle in the District after 30 days of establishing residency or seeking a **Resident Out-of-State Auto (ROSA)** exemption.
