

## FAQs

### 2016 Parking Meter Rate Increase

The District Department of Transportation (DDOT) is scheduled to implement adjusted parking meter rates to \$2.30 as part of the Fiscal Year 2016 Budget Support Clarification Temporary Amendment Act of 2015.

**1. *Why is the District increasing the meter rate?***

- The new rate structure was ordered by the Council of the District of Columbia as part of the Fiscal Year 2016 Second Budget Clarification Temporary Amendment Act of 2015 and establishes parking meter rates at \$2.30 an hour for passenger vehicles citywide.

**2. *When will the new meter rate take affect?***

- June 1, 2016. DDOT has prepared and coordinated with its parking meter vendors to update the software and programming for 14,000+ multispace and single-space meters, as well as the city's pay-by-phone system in order to activate the new rate on June 1.

**3. *What meters are affected by this rate change?***

- **Premium Demand Zones** will go from \$2.00 to \$2.30 an hour.
- **Normal Demand Zones** will go from \$0.75 to \$2.30 an hour
- **Commercial Loading Zones** will go from \$2.00 to \$2.30 an hour
- **Motorcycle Parking** will be \$0.25 an hour citywide.

**4. *Are commercial loading zones included?***

- Yes, commercial loading zones are included. However, commercial vehicle operators have the option of purchasing annual passes for \$323, day passes at \$25, or pay-by-phone for loading zone use. **6. *How do you justify raising the meter prices from \$.75 to \$2.30, or almost 200% in Normal Demand Zones?***

- The new rate structure was ordered by the Council of the District of Columbia as part of the Fiscal Year 2016 Budget Support Clarification Temporary Amendment Act of 2015.

**7. *How much revenue is these higher meter rate expected to generate, and how will that money be used?***

- The new meter rate is expected to generate revenue upwards of \$2 million in FY16. The increase will contribute to the District's share of the Washington Metropolitan Area Transit Authority (WMATA) operating budget.

**8. *Who decided that it was necessary to standardize rates across the city, what's the justification?***

- The new rate structure was ordered by the Council of the District of Columbia as part of the Fiscal Year 2016 Budget Support Clarification Temporary Amendment Act of 2015.

**9. *Do any other local jurisdictions have meter rates as high as this, and if not how did the District settle on such an outrageous number?***

- Other major cities such as New York City, Los Angeles, San Francisco, and Chicago have meter rates ranging from \$3-\$6 an hour.
