Suspension of Work in the District of Columbia

WMATA SafeTrack Surge #10 – Public Space Suspension October 29, 2016 – November 22, 2016

Due to the upcoming WMATA SafeTrack Plan, Surge #10, in the District, **all construction activities in the Public Right-of-Way will be suspended on roadways in the following locations listed below from Saturday, October 29, 2016 – Tuesday November 22, 2016.** This is an effort to eliminate impacts to pedestrian and vehicular traffic in the immediate areas affected by WMATA's expanded bus service for Surge 10 to the affected METRO Stations (Fort Totten, Brookland-CUA, Rhode Island Avenue- Brentwood, & NOMA-Gallaudet University).
