The Process To Participate

- Employees who are eligible to enter the competition are:
- Employed for at least one year
- Operate equipment for at least one year
- Free of a preventable accident on the job for the past 12 months
- Hold valid and appropriate licenses for the equipment he or she will operate (including CDL and medical card). Drivers will compete in full uniform and safety devices.

The competitor must participate in these two (2) areas:

1. Inspection Procedures: Operators will inspect a vehicle to identify at least 10 missing or disabled mechanical and vehicle parts. Each correct answer is worth 20 points, for a maximum of 200 points.

2. Equipment Operation: This is the **Main Event** and the final competition. During this phase, the operator will navigate an obstacle course or will be required to operate the equipment in a challenging manner to demonstrate his or her knowledge and skill in the equipment operation. Each competition includes a different set of skills that are tested and scored according to the obstacle course.

Operators with the highest combined final score earned from the two areas (1. Inspection Procedures and 2. Equipment Operation) will be the winners. Awards will be given to the 1st and 2nd place winners; they will also represent the District of Columbia Government in one of the seven (7) official equipment events conducted at the **Regional APWA Roadeo in Fredericksburg, Va., May 10th – 12th, 2017**.
