

1) 800 block of Upshur Street NW: Mixed-use block with commercial buildings with no meters and residential dwellings with dedicated RPP spots.

Recommendations:

- Install missing RPP sign at 809
- Install missing “no parking entrance” at 814
- Install missing RPP sign at 824
- Relocate ZipCar spaces to the 4100 block of 9<sup>th</sup> Street to increase available business and residential parking

2) 4200 block of 9<sup>th</sup> Street NW: Commercial block with a loading zone, meters, and a variety of parking restrictions.

Recommendations:

- Remove all meters
- Install “no parking entrance” in front of Marshalls Funeral
- Remove 15 min parking restrictions
- Install 2 hr parking limits signs on both sides 9am-6:30pm

3) 4100 9<sup>th</sup> Street NW: Mixed-use block facing a park with meters and no RPP.

Recommendations:

- Change meters from 1 hr parking to 2hr parking 9am-6:30pm
- Review curb cuts at the Centro Evangelico
- Create ZipCar spots
- Add RPP signage in front of residences

4) 800 Block of Taylor Street NW: Residential with a Recreational Facility.

Recommendations:

- Install missing “do not park” sign near the intersection with Georgia Ave/9<sup>th</sup> Street on the SE side.
- Install missing RPP 2 hr 7-8:30 signs on south side

5) 4100 Georgia Avenue NW: Mixed-use with park on one side with meters and RPP restrictions.

Recommendations:

- Add “no parking entrance” signs to the front of 4100 Georgia Ave. building
- Change meters from 1 hr parking to 2hr parking 9am-6:30pm and replace meters where missing.

6) 900 block of Taylor Street NW: Mixed-use with no RPP restrictions.

Recommendations:

- Make the building 4100 Georgia Avenue RPP eligible
- Install 2 hr parking restrictions 9am-8:30pm on north side
- Cut back bush or relocate u-post near Kansas Ave

7) 4100 Kansas Avenue NW: Commercial block

Recommendation:

- Add 2 hr restriction for spot behind 4100 Georgia Ave
- Install “no parking” sign at the corner of Kansas & Taylor

8) 4000 block of Georgia Avenue NW: Mixed-use with residential uses on one side and commercial on the other.

Recommendations:

- Review bus zone to ensure correct length
- Remove “no parking in entrance” sign
- Install 2hr parking restrictions on eastside Mon-Fri 9am-8:30pm

9) 900 block of Shepherd Street NW: Residential with RPP and no immediate or visible issues.

Recommendations: None

10) 800 block of Shepherd Street NW: mixed-use with a police substation and no RPP restrictions.

Recommendations:

- Install 2hr meters 9am-6:30pm in front of businesses from 826 to Georgia Avenue
- Remove “left lane must turn left” sign
- Recommend RPP petition process for residences on the south side of street

11) 3900 Georgia Avenue NW: Mixed-use with some RPP spots.

Recommendations:

- Remove loading zone in front of 3930
- Review bus zone to ensure correct length
- Install 2 hr meters 9am-6:30pm with RPP exemptions on east side where current RPP spots are located
- Add 2 hr meters 9am-6:30pm on west side

12) 800 block of Randolph Street NW: residential with a funeral home with RPP.

Recommendations:

- Install missing u-post on north side near Georgia Ave
- Install missing u-post on south side near Georgia Ave, (no RPP in front of funeral home)
- Review correct distance from intersection for parking regulations
- Possible RPP only on one side

13) 900 block of Randolph Street NW: Residential with a Safeway.

Recommendations:

- Replace missing RPP sign in front of 973
- Missing RPP signage all along north side

14) 3800 block of Georgia Avenue NW: Mixed use.

Recommendations:

- Remove loading zone in front of 3815
- Install meters on the eastside when bus stop is relocated.

15) 900 block of Quincy Street NW: residential with RPP.

Recommendations:

- Review U-post near fire hydrant for adequate position
- Restrict parking to RPP only on north side
- Install 2hr meters along Park Place property 9am-6:30pm

16) 3700 block of 9<sup>th</sup> Street NW: Residential with RPP.

Recommendations:

- Install RPP only parking on the west side.

17) 3700 block of Georgia Ave NW: Mixed-use missing any regulatory signs.

Recommendations:

- Install 2 hr meters on eastside 9am-6:30pm

18) 800 block of Quincy Street NW: Residential with RPP.

Recommendations:

- Ensure and increase RPP enforcement (DPW).

19) 3700 block of New Hampshire Ave: Residential with a church and RPP restrictions.

Recommendations:

- Clarify signs at 3722
- Ensure bus pad and no parking signs are adequate
- Install meters along south side from 3713 to Georgia Avenue
- Install no parking sign near intersection of Georgia Avenue

20) 700 block of Rock Creek Church Road NW: Mixed-use with RPP.

Recommendations:

- Install 2hr parking limit or loading zone from 807 to Georgia
- Add 2hr RPP or No Parking in front of Tiny tot from 8<sup>th</sup> street to 807

21) 800 block of Rock Creek Church Road NW: Residential with RPP.

Recommendations:

- Replace fallen U-post
- Remove sidewalk closed sign at the intersection with 9<sup>th</sup> street

22) 3500 block of Rock Creek Church Road NW: Residential with a school

Recommendations:

- **Install ADA compliant sidewalks on the Westside with parking restrictions**

23) 3600 block of New Hampshire Avenue NW: Residential with RPP.

Recommendations;

- Replace missing RPP sign and no parking on Westside near bus zone
- Ensure bus pad and no parking signs are adequate

24) 800 block of Princeton Street NW: residential with no RPP.

Recommendations:

- Add parking to both sides of the street, but ensure clearance for buses turning from New Hampshire
- Install 2hr meters

25) 3600 block of Georgia Avenue NW (Future CVS site): Commercial.

Recommendations:

- Remove bus stops on both sides and install 2hr metered parking

26) 700 block of Princeton Place NW: Mixed-use with RPP.

Recommendations:

- Install 2hr meters for the two spots near Fisherman of Men Church on the north side

27) 700 block of Quebec Street NW: Mixed-use with RPP.

Recommendations:

- Install 2hr meters from alley to Georgia on the south side
- Create loading zone from alley to Georgia on the north side

28) 800 block of Otis Place NW: Mixed-use with RPP

Recommendations:

- Install no parking during school days 7am-6:30 pm
- Replace two missing RPP U-posts and signs
- Install missing no parking signs near EL Haynes parking

29) 700 block of Otis Place NW: Mixed-use with RPP.

Recommendations:

- Move stop signs to add one parking spot on each side near Georgia Ave intersection

30) 3600 block of Georgia Ave, south of Princeton Street NW: Commercial

Recommendations:

- Replace signage and meters to reflect 2hr parking
